Pursuant to Regulation 30 read with Part A of Schedule III of the SEBI [LODR Regulations], 2015, we hereby inform you that the Company had, on November, 2017, allotted 4,80,00,000 warrants to Opelina Finance and Investment Limited, a promoter group entity, on preferential basis.
